Lake Report

- Arch on OHA property Ken requested a couple times for the homeowner at the end of the Eastern Shoreline to remove an arch that is sitting on OHA property and it has not been moved. Due to the weather, the board will give the homeowner until May 2nd to move the arch off of OHA property. If not, Matt will send out a letter giving a deadline of May 15th. If not moved by May 15th, the Lake Management Committee (LMC) will take it down and dispose of it. Brad volunteered to communicate to the homeowner of the board's request.
- Lake Charles
 - Oxygen monitor for Lake Charles The Chicago EPA has offered OHA an oxygen sensor to monitor Lake Charles oxygen levels. The meter is a \$100 value and is better quality than the current monitor used.
 - Algae contract is set up for this year and McCloud will be treating the curly leaf pondweed early Springtime.
 - Lock n' Dock no one has signed up yet for the upcoming season.
 - OHA website verbage under the Lake Charles tab will be changed to our current lock n' dock rules as published in the most recent directory. Brad spotted the wording and the change will be removing the word "permanently" where it indicates the time period that homeowners can keep boats stored in lock n' dock area.
