Warm weather is around the corner! I hope everyone's 2019 has started off well. With Spring near, a lot of community events will follow soon. Please keep an eye out on the Village's website, Facebook & Nextdoor for updates. Below are a few items

addressed at the Village Board the past few months.

<u>2019 – 2020 Village Budget</u>

The Village creates and approves an annual budget (May 1st – April 30th Fiscal Year). A budget workshop will be held in early April to finalize what the board feels it should prioritize for the next fiscal year. To ensure government transparency, budget meetings and workshops are open to the public, and are available via the internet. Please reach out to me if you cannot make a workshop. I want to hear your feedback or idea you may have. After the workshops the Village prepares a draft budget, which is voted on by the Village Board, typically in late April or early May.

Steve Riley Sworn in as New Fire Chief

At the February 28th Village Board Meeting, Steve Riley was sworn in as the new Westmont Fire Chief. Steve has worked for the Village since May of 1997, starting out as

Severe Weather Preparedness Month

To help people better prepare for weather emergencies, the Illinois Emergency Management Agency (IEMA) and local emergency management agencies promoting Severe Weather Preparedness Month throughout the month of March. FEMA offers a FREE mobile app that provides fast and reliable weather alerts from the National Weather Service (NWS). The app can be tailored to offer alerts for up to five different locations nationwide. The mobile app can also help you locate open shelters and disaster resource centers near you in the event of an emergency. Westmont Students Win Regional Model Water Tower Contest

At the 3rd annual Westmont area regional model water tower event on Saturday, February 23rd, more than 20 teams comprised of over 40 students from throughout the area participated. The top three finishers were all from Westmont! This is a great way to promote the importance of our water distribution systems as well as introduce young people to the possibility of a career as a water works professional. Jose Velez Hernandez, from Westview Hills Middle School took first place. Second place went to Hemza Bedeir from Westmont Jr. High School. Westview Hills Middle School's Oliver Stehik took third place. All 3 of the top finishers will move on to the State Competition later this year! Congrats to our top three finishers and all the participants involved in the contest.

DuPage County Offering Scholarships

I felt it worthwhile to share that the DuPage County Department of Community Services is offering college and occupational training scholarships for low-income individuals with high academic potential. The Community Services Block Grant scholarship supplements the cost of tuition, books, supplies and other school-related items for a semester or a quarter to offset the student's needs. This scholarship is funded and designed in cooperation with the Illinois Department of Commerce and Economic Opportunity.

Applicants are required to provide proof of DuPage County residency, gross household income for the past 90 days and information about members living in the household. Income for the household must be at or below 125 percent of the federal poverty level. Applicants must also include a 500-word original essay or personal statement, official school transcripts, two letters of recommendation, a Financial Aid Audit (financial aid award letter) and proof of enrollment in an Illinois accredited institution. The scholarship award amounts will vary this year from \$500 to \$2,500, and special consideration is given to students interested in high-technology fields or other occupations in emerging fields.

Applications are available at the DuPage County Department of Community Services Office, 421 N. County Farm Road, Wheaton, or online at dupageco.org/CSBG. Completed applications and support documents must be

received by 4:30 p.m. Friday, May 3rd. For more information, contact the DuPage County Department of Community Services at 630-407-6500, or call the toll-free number at 800-942-9412. TTY access is available at 630-407-6502.

Westmont News: From the Westmont Planning & Zoning Commission



A recap of the November thru February P&Z Meetings indicates a common theme. As large scale projects get underway, economic investment in local properties takes place.

Combining the 4 months' agendas, we saw the Burger King at the corner of

63rd Street and Cass propose a major renovation. One of the older style BK's in the area, the new neighbors have influenced this investment. Also in this area, Dotty's Café is relocating to Falcon Center at 65th and Cass Avenue.

We saw a Burlington Avenue office/residence return twice as plans were tweaked and upgraded. With a multi-million dollar project getting ready to launch, the time for neighboring properties to upgrade is now.

Taco Express, closed due to fire came before us to showcase plans to move a few doors west to 13. W. Quincy, former home of the Westmont Newsstand.

2019 promises to see substantial work on our big 7 and here's a brief recap of the Big Seven....

- Oakbrook Hills Redevelopment with an ownership change to the property which included acquisition of the golf course, all expansion plans are on hold. The recently completed and debuted 20+ million dollar renovation is complete, the Hilton brand remains and the current staff has been green lighted to continue building the business portfolio.
- Natatorium storm water detention was completed before Christmas and foundation work has continued the entire winter.

- Market Centre the long awaited 63rd Street & Cass Avenue redevelopment is in full demolition with the last tenant departed. LA Fitness, an 8-12 screen movie theater, several restaurants, and perhaps a shop or two are planned.
- 4. One West Quincy Moving towards property closing and transfer in the next 30 days.
- 5. One North Cass still on the drawing board. Mixed use with residential, parking and retail.
- Oakmont Drive Major construction is underway.
 This will be a Class A office building bringing in large tenants.
- 7. Public Works Facility In the bond phase right now with construction slated to start this summer.
- 8. Finally, BMW enters the final phase of their expansion with the demolition of the "old" facility.

The Village of Westmont Planning and Zoning Commission meets on the second Wednesday of each month at 7:00pm in the Village Hall. All meetings are televised live on local cable access channel 6 and then replayed at 10:00am Monday through Friday. Agenda items are then sent to the Village Board with the comments of the Commission for final disposition. You can also view the agenda on the Village website — www.westmont.il.gov. The next meetings will take place March 13th, April 10th and May 8th — tune in!

Westmont High School

The 2018 Challenge Index National Ranking has been published. The America's Most Challenging High Schools ranks schools through an index formula that's a simple ratio: the number of Advanced Placement, International Baccalaureate and Advanced International Certificate of Education tests given at a school each year, divided by the number of seniors who graduated that year. A ratio of 1.000 means the school had as many tests as graduates.

1. Nature of Organization

The Association was incorporated under the laws of the State of Illinois as a not-for-profit corporation to administer and operate the property known as Oakwood Homeowners Association located in Westmont, Illinois, pursuant to and in accordance with the Homeowners Association Declaration of Covenants, Conditions and Restrictions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounts are maintained on the cash basis. Accordingly, no liabilities or receivables have been recorded.

Estimates and Assumptions

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities and disclosure of contingent assets and inabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates. Since these financial statements have been prepared on the cash basis, no liabilities have been recorded.

The Association has the option to file income tax returns as a homeowners associationunder Section 528 of the Internal Revenue Code, or as a regular corporation.

For the year ended December 31, 2018, the Association has elected to file as a regular corporation. This will allow the Association

to pay the least tax possible. For the Association had a profit that will be adjusted against the prior years' NOL (Net Operating Loss) carryover. These returns will be filed by the Association and are due by March 15, 2019.

Property and Equipment

Real property and common areas acquired from the developer and related improvements to such property are not recorded in the Association's financial statements as assets because those properties are owned by the individual unit owners in common and not by the Association. There were no such items added during the 2018 year.

A \$6,157.50 Certificate is held at TCF Bank with an interest rate of 1.49% matures on 07/22/19. A \$48,895 Certificate is held at Oxford Bank with an interest rate of 1.36% matures on 02/99/2019. A \$10,000 Certificate is held at Republic Bank with an interest rate of 2.25% matures on 07/09/19. A \$30,303.95 Certificate is held at Republic Bank with an interest rate of 2.25% matures on 12/11/19. Funds of \$40,003.58 are deposited into a Money Market account with an interest rate of 2.25% matures on 12/11/19. Funds

4. Replacement Fund

Certain funds of the Association are restricted by the Declaration of Ownership as wellas by Board designation for the long-term maintenance of the Association's common property.

The Association has not conducted a study to determine the remaining useful lives of the components of common property because of the limited amount of common hereinsts. When replacement funds are needed to meet future needs for major repairs and replacements, the Association has the right to increase regular assessments, pass special assessments, or delay replacement unit until funds are available. The effect on future assessments has not been determined at this time.
